ATTORNEYS: USE NEW ATTORNEY PORTAL TO SIGN UP FOR COURT'S NEW LACOURTCONNECT REMOTE COURTROOM APPEARANCE

The Attorney Portal and LACourtConnect make your remote appearance scheduling as easy as 1-2-3.

1. At the Attorney Portal, create your online Court identity – your Court ID. It's a one-time process.
2. Within the Attorney Portal, click to go to LACourtConnect and schedule your remote appearances.
3. Use LACourtConnect's video and audio technology to participate remotely in your scheduled hearings.

CREATE YOUR COURT ID STARTING JUNE 7

Effective **June 7, ALL** attorneys are encouraged to create their Court ID at the **Attorney Portal**:

- Go [here](#) on Monday, June 7, 2020 to **create** a Court ID consisting of your email address and password.
- Your Court ID is a single sign-in credential that gives you access to basic features of the Attorney Portal and all features of LACourtConnect.
- Each member of your support staff can also create a Court ID, so they can schedule remote appearances on your behalf.

SCHEDULE YOUR REMOTE APPEARANCE

Effective **June 15, Probate attorneys and attorneys with Mandatory Settlement Conferences** are encouraged to:

- Sign in to the Attorney Portal on June 15 with your Court ID and go to LACourtConnect.
- **Schedule** remote appearances **ONLY** for Probate and Civil Mandatory Settlement Conferences for cases on calendar the week of **June 22** and thereafter.
- A Help Center on the Attorney Portal pages will link you to full instructions, instructions by topic and contact information for help.

PARTICIPATE IN YOUR REMOTE HEARING

Effective **June 22, Probate attorneys and attorneys with Mandatory Settlement Conferences** should sign in at least 15 minutes before the scheduled hearing by following the link (for video appearances) or calling the number (for audio-only) provided in the confirmation email you receive when you schedule the appearance.
